

## COMPETITION

### Rules

3. All entries must be submitted by 23.59 on 15 July 2017. Send an e-mail titled "BWSO comp" with the answer to the question "Which is the UK's smallest breeding owl?" to [sleepoutcomp@rspb.org.uk](mailto:sleepoutcomp@rspb.org.uk) One entry per person. Please provide a contact telephone number.
4. The RSPB must receive entries by 23.59 on 15 July 2017. Any entry which is late, incomplete or inappropriate will be deemed invalid at the discretion of the RSPB.
5. The RSPB accepts no responsibility for any technical failure, malfunction or any other problem with any server, internet access system or otherwise which may result in any entry being lost, corrupted or not properly registered or recorded. No responsibility will be taken for damaged or lost entries.
6. The judges shall assess the entries and one winner will be selected at random. The judges' decisions shall be final. No correspondence regarding the results will be entered into.
7. The winner shall receive a Big Wild Sleepout kit which includes a £500 gift voucher supplied by Rohan and a selection of RSPB nature goodies worth nearly £100. The prize will be sent to the winner by post within 28 days of the winner responding to notification from the RSPB that they have won.
